
Enclosed is the supplemental affidavit which we are filing to amend the initial affidavit we filed in 1997 where we were asked to report our anticipated contributions.

As we discussed in our telephone conversation today, we were unaware that the initial affidavit was asking us to report anticipated contributions over the life time of the partnership and not just expected contributions for fiscal year 1997. We are therefore reporting anticipated contributions to be Five Hundred Million dollars over the life time of the Partnership.

We wish to clarify that the Five Hundred Million dollar figure is simply a guess as to the anticipated contributions over the lifetime of the partnership. It is not the fair or book value of the partnership, nor the amount of capital actually contributed by the limited partners.

We are therefore writing this letter to serve as a record so that no person, entity or governmental agency, who may view this affidavit, should be confused as to the actual amount of contributions made by the limited partners to the partnership to date. Actual contributions to date are shown on the 1998 annual report.
