



3. There are no further capital contributions anticipated from the limited partners.

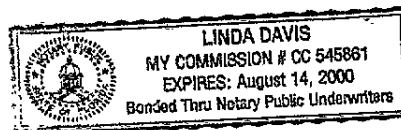
