**AMENDED AND RESTATED CERTIFICATE OF LIMITED PARTNERSHIP OF

Pursuant to the provisions of Section 620.109 of the Florida Statutes, the undersigned, being the sole General Partner of **KORMAN INVESTMENTS LIMITED PARTNERSHIP**, hereby duly executes and files with the Florida Secretary of State this Amended and Restated Certificate of Limited Partnership.

1. The present name of the limited partnership is "**KORMAN INVESTMENTS LIMITED PARTNERSHIP**" (the "Limited Partnership").

2. The original certificate of limited partnership for the Limited Partnership was filed on December 11, 1997.

3. The initial General Partner of the Limited Partnership, Harry B. Korman, as Trustee of the Harry B. Korman Revocable Trust Agreement dated June 13, 1994, has withdrawn as General Partner. The partners of the Limited Partnership have elected to continue the business of the Limited Partnership and have admitted **KS INVESTMENTS, LLC**, a Florida limited liability company, as the new General Partner of the Limited Partnership.

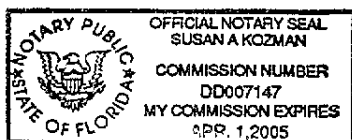

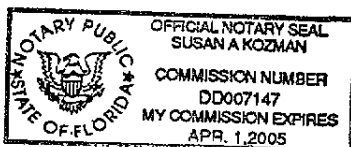


