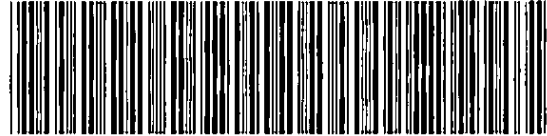

**CERTIFICATE OF AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP
OF SILVER-GREEN, LTD., a Florida limited partnership**

THE UNDERSIGNED, as General Partner of SILVER-GREEN, LTD., a Florida limited partnership, whose Certificate was filed with the Florida Department of State on December 12, 1997 and assigned Florida document number A97000002701, as amended on December 17, 1998, being the sole General Partner thereof, makes the following statement for the purpose of amending the Certificate of Limited Partnership previously filed with the Secretary of State, State of Florida, to-wit:

That pursuant to the Limited Partnership Agreement establishing SILVER-GREEN, LTD., the Partners voted affirmatively to accept the following amendment to the Certificate of Limited Partnership:

1. That paragraph 6 of the Certificate of Limited Partnership of SILVER-GREEN, LTD. is hereby deleted in its entirety and the following is substituted therefor:

"6. The latest date upon which the Partnership is to dissolve is March 1, 2034, unless otherwise continued in accordance with the terms of an Amendment to this Certificate of Limited Partnership."

2. That the General Partner and the Limited Partners hereto acknowledge that, except as herein otherwise set forth, all of the terms, covenants and conditions of the Limited Partnership Agreement dated December 12, 1997, and any and all other documents relating thereto, shall remain in full force and effect as written.
