

2. At this time, it is not anticipated that additional capital contributions will be made by the limited partners.



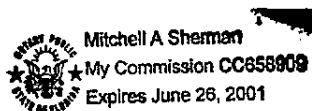
