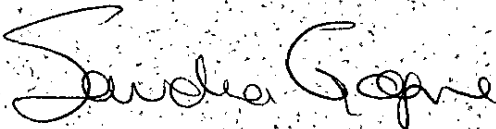
Thank you for your time regarding the reinstatement of the referenced corporation.
