

I spoke with you this morning about the vicious cycle I'm in in my attempt to dissolve Oviedo Grove Limited Partnership. You said you'd try to help.

I submitted dissolution documents on a number of corporations and limited partnerships a few months ago. Each of the corporations was the general partner of one of the limited partnerships. Your division returned to me all the limited partnership dissolution documents and asked me to resubmit them on different forms. I did so.

As a result of my limited partnership dissolution documentation error, all the corporations were dissolved on one date and (all but one) limited partnerships at a later date.

You returned only one of the limited partnership dissolution requests, saying that the limited partnership could not be dissolved if its general partner was not active, even though your department kindly dissolved the other limited partnerships without active general partners.

Anyway, I hope I've refreshed your memory enough to see I'm in a hopeless Catch-22 and really just want to dissolve Oviedo Grove Limited Partnership, and this will be the end of it.
