CERTIFICATE OF LIMITED PARTNERSHIP OF
PARK CREST, LTD.**

Pursuant to the authority of Section 620.109 of the Florida Revised Uniform Limited Partnership Act (1986), the undersigned, constituting the managing general partner of PARK CREST, LTD., a Florida limited partnership (the "Partnership"), submits the following:

1. The current name of the Partnership is PARK CREST, LTD.
2. The date of the filing of the original certificate of limited partnership of the Partnership was March 5, 1998 (the "Original Certificate").
3. The Original Certificate was amended pursuant to the filing of that certain Amendment to Certificate of Limited Partnership dated as of September 7, 1999 and filed with the Florida Secretary of State on September 8, 1999 (the "Amendment to Certificate of Limited Partnership").
