My father established a Family. Please help me with the following situation. My father established a Family. Limited Partnership. He passed away in July of 2002. He apparently took care of this situation in the past, though I do not know who did the year before this one, perhaps the attorney settling the estate. On line it states the document was filed electronically. Anyway, in June of 2004 the attorney changed the registered agent from my father's name and address in Sarasota, Florida to mine in Brandon, Florida.

I NEVER received notification to file a form regarding this until October of 2004. When I received the post card at my Brandon, Florida address in my name, perhaps because the registered agent had been changed to me, I went on line and processed the form. On line it said if you did not receive notification the \$500.00 fee would be waived and I checked that box. I then sent in the form. On November 10, 2004 I received a letter stating I owed \$50.00, which I sent for the filing.

In the meantime, in November the manager in the office at my parents. condominium in Sarasota called to tell me the mail carrier brought her a large amount of mail from my mother's mail box, some of which was government related that had been left for a long period of time. The manager then put it in a large envelope and mailed it to me in Brandon, Florida. The mail boxes all open at once so the carrier can easily see inside of them, so why he left it pile up is beyond me. We have had a forward to my mothers address in Florence, South Carolina since my father passed away. Even when my mother is in Florida she DOES NOT deal with the mail. The bank in Ohio where my



father set up their trusts pays all of my mother's bills and my brother-in-law in Florence, S.C. and I attempt to deal with any loose ends. Therefore all mail is forwarded permanently. Anyway, the mail I received from the box in Sarasota dated back all the M 1: 48 way to April of this year. The notification post card from you was in with that mail. The post office did admit they have a forward and said the mail carrier was remissa difference, they would provide me with a letter, should I need it for any of the mail left sitting.

Some of the mail was certified, there were even triplicates of notifications from the IRS!

Today, December 28, 2004 I received notification I have until January 1, 2005 to submit \$526.25 or I would have to submit an additional \$526.25. This leaves me no time to look into this situation. There was a number (850) 245-6967 to call with any questions. I have attempted to call the number numerous times today, Tuesday, December 28, 2004, and no one answers. I have a feeling the office is CLOSED for the holiday and will not be open until after January 1st! This leaves me in a difficult situation. If I don't mail the fee, you will bill me double. I can't reach anyone to talk to, and I have been left with only a few days to get this to you without penalty.

Please contact me to clear this situation up. I feel the enclosed check should be refunded. Thank you.
