

## CERTIFICATE OF DISSOLUTION FOR TEMPUS PALMS INTERNATIONAL, LTD.

Pursuant to the provisions of section 620.1203, Florida Statutes, this Florida limited partnership, whose certificate was filed with the Florida Department of State on March 19, 1998, assigned Florida document number A98000000724, hereby submits this Certificate of Dissolution.

FIRST: Reason for dissolution:

This Certificate of Dissolution is being submitted on behalf of Tempus Palms International, Ltd. (the "Partnership") in connection with that certain Order Approving Debtors' Amended Disclosure Statement and Confirming Debtors' Amended Plan of Reorganization As Modified, issued May 5, 2011 by the United States Bankruptcy Court, Middle District of Florida, Orlando Division, Case No. 6:10-bk-20709-KSJ (the "Order"). The Order provides that all assets of Tempus Marketing International, LLC ("TMI"), including TMI's general partnership interest in the Partnership shall vest in Mystic Dunes, LLC ("Mystic Dunes"). Further, the Order authorizes and directs Mystic Dunes and the Partnership to issue, execute, deliver, file and record any document and to take any action necessary or appropriate to implement, consummate and otherwise effectuate the Debtors' First Amended Joint Plan of Reorganization filed on March 22, 2011 (the "Plan"). Pursuant to the Plan and the Order, the Partnership is directed to file this Certificate of Dissolution with the Florida Department of State.
