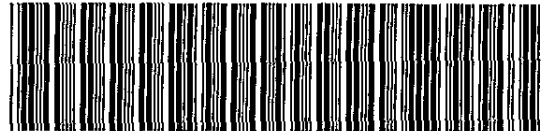



**SECOND:** This certificate of cancellation shall be effective as of December 31, 2002 when the partnership filed its final income tax return.


