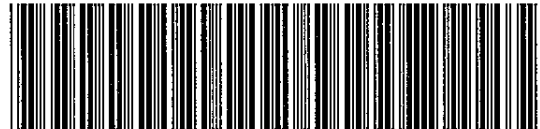

If you recall, we spoke on Tuesday, November 18, 2003 regarding Limited Partnership Reinstatement for The Brooks Partnership, Ltd. (hereinafter "the Partnership"). 
