1. The name of the Limited Liability Limited Partnership is Birchwood Acres Limited Partnership, LLLP, a Florida limited liability limited partnership, which on July 30, 1998, filed a certificate of limited partnership (the "Certificate") with the Florida Secretary of State, Division of Corporations and which on January 12, 2001, filed a Statement of Qualification electing to be a limited liability limited partnership. On the date hereof, Three E Corporation, the former general partner of the Limited Liability Limited Partnership, assigned its interest in the Limited Liability Limited Partnership to the General Partner.

2. The Certificate is hereby amended as follows:

(a) On the date hereof (i) the General Partner has become and is now the sole general partner of the Limited Liability Limited Partnership thereof; (ii) Three E Corporation has withdrawn from the Limited Liability Limited Partnership as a partner thereof; and (iii) the general partner of the Limited Liability Limited Partnership is hereby changed to VII GP Harmony, L.L.C., a Delaware limited liability company.

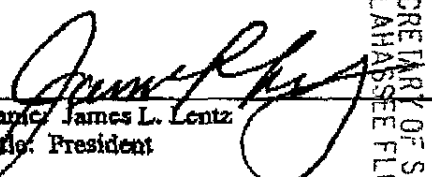
