**FIRST AMENDMENT TO THE CERTIFICATE OF LIMITED PARTNERSHIP

The name of this limited liability limited partnership is HOOKS PROPERTIES, LLLP.




**IV. NAME AND BUSINESS ADDRESS OF THE GENERAL PARTNER**




