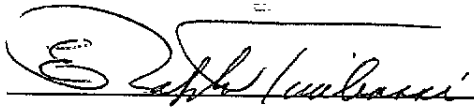
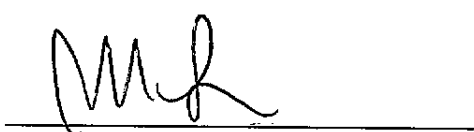
(b) any event of dissolution or termination as described in the Amended and Restated Limited Partnership Agreement of LTK Investors, Ltd., dated August 17, 2001.

This amendment is being filed within 30 days after the admission of a new general partner to the partnership which occurred on August 17, 2001.

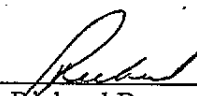

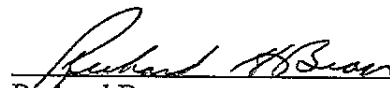
