- B. the sale, abandonment or disposal by the limited partnership of all or substantially all of its assets;

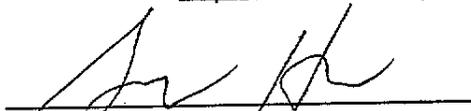

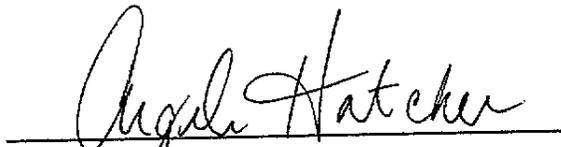
