Enclosed on behalf of Twin Oaks at Pass Christian Limited Partnership (the "Partnership"), Document Number A98000002547, are the following documents for filing in the same order in which they are listed:

1. Supplemental Affidavit of Capital Contributions for a Florida Limited Partnership (the "Supplemental Affidavit") together with check number 1273 in the amount of \$1,750.00 in payment of the filing fee; and
2. Limited Partnership Uniform Business Report due May 1, 2002 ("UBR") together with check number 1272 in the amount of \$926.25, which includes a late fee of \$400.00.

Twin Oaks Development Corporation (the "General Partner") became the sole general partner of the Partnership as of December 1, 2001. The original general partner filed an Affidavit of Capital Contributions for Florida Limited Partnership on November 12, 1998 showing the amounts contributed and anticipated to be contributed by limited partners to be zero and stating by way of annotation to the form that a supplemental affidavit would be formed when the amounts to be contributed were settled. This supplemental affidavit was never filed.

Accordingly, General Partner encloses the Supplemental Affidavit for filing. The amount of capital contributions stated is \$2,750,000.00, which represents the amount of capital contributed to date together with the amount which the partners


