**AMENDMENT TO THE
CERTIFICATE OF LIMITED PARTNERSHIP

THE UNDERSIGNED hereby executes and swears to this Amendment to the Certificate of Limited Partnership of **SKINNER FAMILY LIMITED PARTNERSHIP**, a Florida limited partnership (the "Partnership"), pursuant to the Florida Revised Uniform Limited Partnership Act of 2005, as amended, *Florida Statutes* § 620.1202. **A98000002602**

1. Name of Partnership. The name of the Partnership is **SKINNER FAMILY LIMITED PARTNERSHIP**.

2. Date of Filing of Certificate of Limited Partnership. The Partnership filed its Certificate of Limited Partnership (the "Certificate") with the State of Florida Department of State on November 24, 1998.

3. Amendments to the Certificate of Limited Partnership. The Certificate is hereby amended to reflect:

(a) **B.J. SKINNER, JR.** and **MARY ANN SKINNER** (collectively, the "Withdrawing General Partner") have withdrawn by virtue of the Withdrawing General Partner's transfer and assignment of all of Withdrawing General Partners' interest as general partner of the Partnership.

(b) **JOHN C. SKINNER** (the "New General Partner"), whose address is 1309 N. Florida Avenue, Tampa, Florida 33602, is the new general partner of the Partnership by virtue of the New General Partner's approval and acceptance of the assignment of the Withdrawing General Partner's interest as a general partner of the Partnership.

(c) Pursuant to the Florida Revised Uniform Limited Partnership Act of 2005, as amended, *Florida Statutes* § 620.1702, the partners of the Partnership have agreed to continue the business of the Partnership.


(d) The Certificate is hereby amended to reflect that the Partnership elects to be a limited liability limited partnership and the complete name of the Partnership shall be **SKINNER FAMILY LIMITED PARTNERSHIP, LLLP**.
