

1. The aggregate capital contributions made by the Limited Partners of the Partnership to the Partnership is \$2,745,000.00.



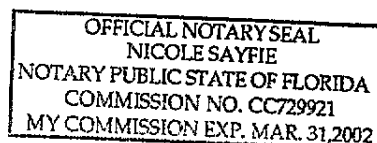
