Pursuant to the provisions of Section 620.1202 of the Florida Statutes, Logan's Pointe Associates, Ltd., a Florida limited partnership (the "Partnership"), whose certificate was filed with the Florida Department of State on January 4, 1999 under Document Number A99000000002, adopts the following Certificate of Amendment to its Certificate of Limited Partnership:

Paragraph 5. of the Certificate of Limited Partnership is hereby deleted in its entirety and replaced with the following:

5. Dissolution Date. The term of the Partnership shall commence on the date of filing of the Certificate of Limited Partnership with the Secretary of State of Florida and shall continue until December 31, 2057, unless sooner terminated as provided in the Limited Partnership Agreement.
