The present law does not allow Florida limited partnerships to use the suffix "L.P."

Please use LTD., LIMITED, or LIMITED PARTNERSHIP.

ALSO, there seems to be a PAGE MISSING. The Certificate of Limited Partnership must also include the NAME AND STREET ADDRESS of the General Partner. And it must be SIGNED by the General Partner.

~ALSO, the WRONG AFFIDAVIT language has been used. The wording on your affidavit is the wording that would be used if the partnership were a FOREIGN limited partnership.

I am enclosing a form for a Florida limited partnership. Affidavit of Capital Contributions.

You must tell us two things. You must first tell us the total limited partner contributions to date. Then you must tell us the TOTAL AMOUNT CONTRIBUTED AND ANTICIPATED TO BE CONTRIBUTED BY THE LIMITED PARTNERS.

Since you already seem to know that this amount will be at least \$250,000, it would be to your advantage to declare a TOTAL ANTICIPATED AMOUNT that you are certain will never be surpassed. Like TEN MILLION DOLLARS. Or whatever.

That way the partnership will avoid the expense -- which could be thousands of dollars -- of filing SUPPLEMENTAL AFFIDAVITS. Please note that the law requires to you declare a DEFINITE TOTAL ANTICIPATED AMOUNT.
