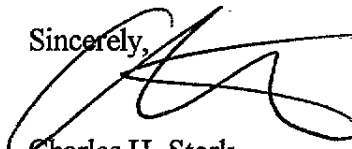

**CERTIFICATE OF AMENDMENT
TO
CERTIFICATE OF LIMITED PARTNERSHIP
OF

Pursuant to the provisions of Section 620.109, Florida Statutes, this Florida limited partnership, whose certificate was filed with the Florida Department of State on January 28, 1999, dated effective January 22, 1999, adopts the following Certificate of Amendment to its certificate of limited partnership.

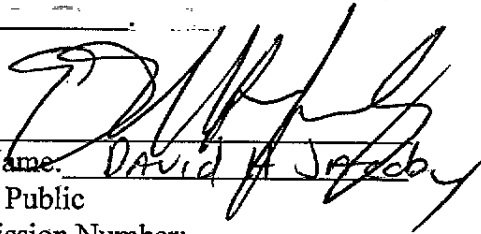

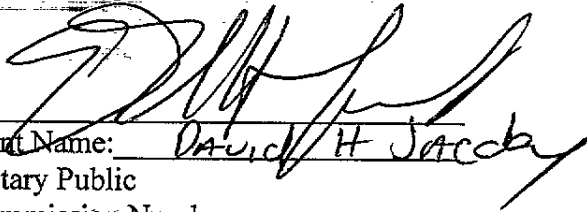
