Pursuant to the provisions of Section 620.1203, Florida Statutes, this Florida limited liability limited partnership, whose certificate was originally filed with the Florida Department of State on February 26, 1999, and was amended and restated and filed with the Florida Department of State on March 13, 2006, and which was assigned Florida document number A99000000311, hereby submits this Certificate of Dissolution.

FIRST: Reason for Dissolution:

Pursuant to the Special Meeting of the Shareholders of R.B. Kempfer Enterprises, Inc., and a Special Meeting of the Board of Directors of R.B. Kempfer Enterprises, Inc., the General Partner of R.B. Kempfer Family Limited Partnership, LLLP (the "Partnership"), and in accordance with the laws of the State of Florida and in accordance with the Amended and Restated Partnership Agreement of the Partnership dated February 21, 2006, it is deemed desirable and advisable, in the judgment of the General Partner for the benefit of the General Partner and Limited Partners, that the Partnership should be dissolved effective November 20, 2013, upon the terms, and subject to the conditions set forth in the Plan of Dissolution, filed with this Certificate of Dissolution as Exhibit "A".

SECOND: A Notice of Dissolution is **NOT** attached to this Certificate of Dissolution.

THIRD: The effective date of dissolution shall be November 20, 2013.
