AFFIDAVIT AND CERTIFICATE OF LIMITED PARTNERSHIP OF TITLE PARTNERS OF SUWANEE,

We, the undersigned, desiring to form a partnership, pursuant to the Florida Uniform Limited Partnership Act as set forth in §§ 620.01 et seq. of the Florida Statutes, do hereby certify:

- 1. The name of the partnership is Title Partners of Suwanee,
- 2. The character of the business intended to be transacted by the partnership is to provide real estate settlement and core title agent services, including the evaluation of title searches to determine the insurability of title, the clearance of the underwriting objectives, the issuance of policies on behalf of title insurers, and the successful conducting of closing and all related activities such as the proper and appropriate, management of escropy accounting etc., and to carry on any and all activities related thereto.
- 3. The location of the principal place of business is to be at 970 Peachtree Industrial Blvd. Suwanee, Georgia 30024, in the County of Gwinnett, State of Georgia and matting address is 1715 N. Westshore Blvd., Suite 990, Tampa, FL 33607.

 - 5. The date at which the partnership will end is the 26th day of February 2019.
