I am responding to your attached letter regarding our Annual Report renewal.

The original filing of the capital contributions affidavit indicated \$581,000 of contributions to date and \$1,000,000 of total anticipated contributions. When filed, I incorrectly interpreted this to mean anticipated in that year. Our limited partnership agreement makes provisions for capital contributions of up to a total of \$5,000,000.
