Pursuant to Florida Statutes Section 620.1202, the Certificate of Limited Partnership of KINGSBAY HOLDINGS, LTD., a Florida limited partnership, is hereby amended as follows:

1. Name. The name of the limited partnership is KINGSBAY HOLDINGS, LTD. (the "Partnership").

2. Filing Date. The Certificate of Limited Partnership was filed with the Florida Department of State on April 16, 1999, and assigned Document Number A99000000620.

3. Amendments.

a. Article Seven is hereby amended and restated in its entirety to read as follows:

"7. This Partnership shall have perpetual duration."

b. Article Nine is hereby added to read as follows:

"9. The interests of the Partnership are securities represented by certificates in registered form governed by Article 8 of the Florida Uniform Commercial Code and shall be treated as securities for all purposes under the Florida Uniform Commercial Code."

4. Effective Date. This Certificate of Amendment shall be effective at the time of its filing with the Florida Department of State.
