


7. The amount of capital contributions to the Partnership made by the limited partners is, in the aggregate, fifty thousand (\$50,000.00 ) Dollars.
8. At this time, it is not anticipated that additional capital contributions will be made by the limited partners.

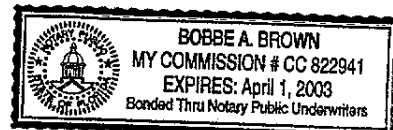
