

7. *Additional Contributions.* No additional contributions of the Limited Partners have been agreed upon.

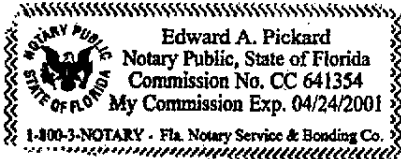
