FIRST: ARTICLE 1 of the limited partnership's certificate of limited partnership is amended to read in its entirety as follows:


1. The name of the limited partnership is CENTRES DESTREHAN LIMITED PARTNERSHIP, a Florida limited partnership (the "Limited Partnership").
