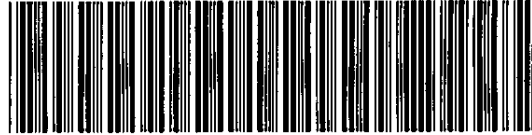



**CERTIFICATE OF SECOND AMENDMENT  
TO  
CERTIFICATE OF LIMITED PARTNERSHIP

Pursuant to the provisions of section 620.1202, Florida Statutes, this Florida limited partnership, whose certificate was initially filed with the Florida Department of State on October 11, 1999 and assigned Florida Document No. A99000001663, and thereafter amended by that certain Amended Certificate of Limited Partnership on September 26, 2006 (the "Amended Certificate"), adopts the following Second Amendment to Certificate of Limited Partnership.

This amendment is submitted to amend the following:

- A. Section 3(c)(i) of the Amended Certificate, is deleted in its entirety and replaced with the following:

*3(c)(i) The business and purpose of the Partnership shall consist solely of the acquisition, operation and disposition of the real estate project known as Tampa Florida Brewing, LTD. (the "Property") and to enter into such loan transactions as the Partnership may determine from time to time with the real property as collateral, including, but not limited to the refinance of any existing indebtedness.*

- B. To the extent the Limited Partnership Agreement, any Amended Certificate, or other Partnership document states that the Partnership may only borrow from LaSalle Bank National Association or any other specifically named lender or financial institution, such reference to a specific financial institution or lender are deleted and replaced with "a financial institution or lender selected by the General Partner".

- C. In all other respects, the Amended Certificate remains in full force and effect.
