HI LIMITED PARTNERSHIP declared a total anticipated limited partner contribution amount of \$70,000.00 on its AFFIDAVIT OF CAPITAL CONTRIBUTIONS.

You can't change the TOTAL ANTICIPATED CONTRIBUTION AMOUNT on an AMENDMENT to the Certificate of Limited Partnership.
