**CERTIFICATE OF LIMITED PARTNERSHIP

The undersigned, desiring to convert from a partnership to a limited partnership pursuant to the laws of the State of Florida, Section 620.8902 of the Revised Uniform Partnership Act of 1995, does hereby execute and file with the Secretary of State of Florida this Certificate of Limited Partnership, as follows:

1. The former name of the partnership was "Fountainview Joint Venture."
2. The conversion of the partnership to a limited partnership was unanimously approved by the partners.


10. All of the Partnership's acts and decisions shall be authorized by the written consent of the General Partner.


