**AMENDMENT TO CERTIFICATE
OF LIMITED PARTNERSHIP OF
JKR FAMILY LIMITED PARTNERSHIP**

Pursuant to the provisions of Fla. Stat. § 620.1202, this Florida limited partnership, whose certificate was filed with the Florida Department of State on November 1, 1999, adopts the following Certificate of Amendment to its Certificate of Limited Partnership.

1. Purpose: the purpose of this Amendment is to elect limited liability limited partnership status and to change the name of the Partnership
2. Amendment: Pursuant to Florida Statutes § 620.1406(1)(a), the Certificate of Limited Partnership is amended as follows:
 - a. New Paragraph 9 is added to the Certificate as follows: Pursuant to Florida Statutes § 620.1201(1)(d), the Partnership elects limited liability status and shall be a limited liability limited partnership.
 - b. Paragraph 1 of the Certificate is amended and restated as follows: The name of the Limited Partnership is JKR FAMILY LIMITED PARTNERSHIP, LLLP.
3. Effective Date: The effective date of this Amendment to Certificate of Limited Partnership shall be the date of filing with the Secretary of State.
4. Approval of Limited Partners: As is evidenced by their signature below, all of the limited partners of the Partnership have approved this Amendment to the Certificate of Limited Partnership of the Partnership in accordance with Fla. Stat. § 620.1406(3).
