We have received your document for STD, LTD. and your check(s) totaling \$1035.00. However, the document has not been filed and is being retained in this office for the following:

The subject limited partnership's certificate of authority was revoked September 26, 2003, for failure to file an annual report/uniform business report.

To reinstate the limited partnership you should file a current annual report/uniform business report/reinstatement, which has been signed by a general partner.

The partnership must pay filing fees totaling \$52.50, an amount equal to the total amount it would have paid this office had it filed its annual reports/uniform business reports in a timely manner. In addition to the filing fees, there is a fine of \$500 for each year or part thereof during which the limited partnership's certificate was revoked for the years 1984 through the present, and \$88.75 supplemental fee per year from 1992 forward. If a registered agent has not been previously designated, an additional \$35 is due to designate the registered agent.

The total amount due to reinstate is \$1,282.50. An additional \$8.75 is due for each certificate of status requested.

So therefore, we will need an additional \$247.50.

Please return your document, along with a copy of this letter, within 60 days or your filing will be considered abandoned.
