The subject limited partnership's certificate of authority was revoked September 26, 2003, for failure to file an annual report/uniform business report.

To reinstate the limited partnership you should file a current annual report/uniform business report/reinstatement, which has been signed by a general partner.

The partnership must pay filing fees totaling \$52.50, an amount equal to the total amount it would have paid this office had it filed its annual reports/uniform business reports in a timely manner.
