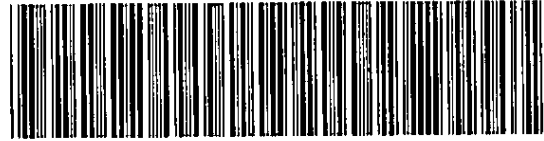

SECOND: The original Certificate of Limited Partnership was filed on November 12, 1999, under the name "Zorka FLP, Ltd." document number A99000001856.

THIRD: The First Amendment to Certificate of Limited Partnership of Zorka FLP, Ltd. changing the name to Zorka FLP, LLLP was filed December 4, 2008.

FOURTH: The Second Amendment to Certificate of Limited Partnership of Zorka FLP, LLLP changing the General Partner was filed on June 11, 2020.


SEVENTH: All debts, obligations, and liabilities of Zorka have been paid or discharged.


EIGHTH: All remaining property and assets held by Zorka have been distributed among its members in accordance with their respective rights and interests.

NINTH: There are no suits pending against Zorka in any court.


