
AFFIDAVIT OF CAPITAL CONTRIBUTIONS

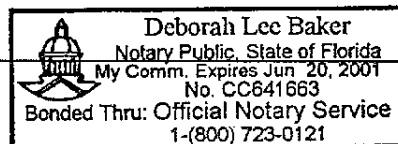

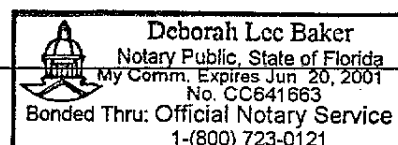
