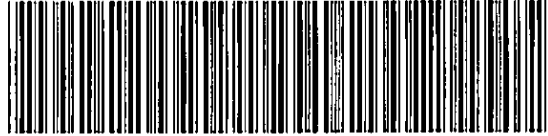

**AMENDMENT TO THE  
CERTIFICATE OF LIMITED PARTNERSHIP  
OF

Pursuant to Section 620.1202, Florida Statutes, the Certificate of Limited Partnership of Riverside Partners, Ltd. (the "Partnership"), filed on November 23, 1999 (the "Certificate of Limited Partnership"), is amended as follows:

1. The name of the Partnership is Riverside Partners, Ltd.
2. The date of filing the original Certificate of Limited Partnership of the Partnership was November 23, 1999.

3. Section 2 of the Certificate of Limited Partnership is hereby amended and replaced in its entirety to read as follows:

"2. The address of the office where records will be kept is c/o Waypoint Residential LLC, 9 W Broad St Suite 800, Stamford, CT 06902. 4. Waypoint Riverside MF-FL Owner LLC, a Delaware limited liability company (the "New General Partner") is substituted as the general partner of the Partnership, replacing the existing general partner ("Existing General Partner"). Section 3 of the Certificate of Limited Partnership is hereby amended and replaced in its entirety to read as follows:

5. Section 4 of the Certificate of Limited Partnership is hereby amended and replaced in its entirety to read as follows:


"4. The street address and the mailing address of the limited partnership is 9 W Broad St Suite 800, Stamford, CT 06902."

6. The foregoing amendment shall become effective when filed with the Secretary of State of the State of Florida.
