Please be advised that I request to have this so-called partnership dissolved at your earliest convenience.

Upon my husband's death in 1999, the C.P.A. who does my taxes suggested that he draw up this partnership to protect my two heirs in the event of my death. At the time it seemed like a good idea, so for \$2,000.00 I was suddenly a corporation. Since that time, the stock market has crashed and the tax laws have changed and I no longer have need for this cash cow for my C.P.A. who charges \$800.00 plus a year to file the necessary tax and corporation returns on a "partnership" on which I don't have enough income to pay taxes.
