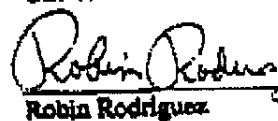
**CERTIFICATE OF AMENDMENT  
TO  
STATEMENT OF QUALIFICATION**

The undersigned, Robin Rodriguez, as the sole general partner of Cordell Funding, Ltd., LLP, a Florida limited liability limited partnership (the "Partnership"), being desirous of amending the Statement of Qualification of the Partnership as filed with the Secretary of State of the State of Florida, hereby states as follows:

1. The name of the limited partnership is Cordell Funding, Ltd., LLP.
2. The Partnership was formed as a limited partnership under the laws of the State of Florida on December 28, 1999, the date on which a Certificate of Limited Partnership of the Limited Partnership was filed with the Secretary of State of the State of Florida under Document No. A99000002225.

Therefore, Paragraph 2 of the Statement of Qualification is hereby amended and restated in its entirety to read as follows as of such date:  
  
"2. The limited partnership adopts the suffix "LLLP" and the name of this entity shall be Cordell Funding, LLLP."
