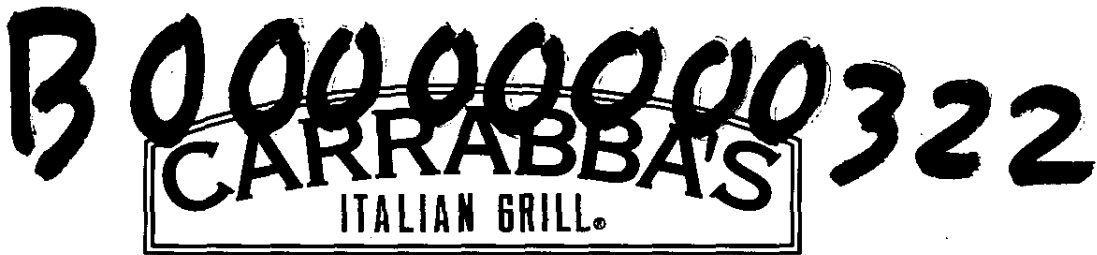


Dear Buck:
