
To Whom It May Concern:

We recently filed a 2002 Uniform Business Report (UBR) for Office Depot of Texas, L.P. We received the documentation and complied with the September 25th due date. We sent in the report with a total fee of \$141.25. The documentation was sent back to us with a letter stating that the amount due should have been \$541.25, which included a \$400.00 late fee. Upon receipt of this documentation I immediately contacted the Division of Corporations and spoke with Justin. I explained that we had filed the report by the mandated due date and questioned the \$400.00 late fee that we were being assessed. He explained that the report was originally due in May 2002 and that was why we were being assessed a late fee. He suggested that I write a letter explaining that we never received any documentation stating that the UBR was to be filed by May 2002. Furthermore, the document filed in September did not state that it was a second notice nor did it mention that an additional \$400.00 was due.

I am enclosing the original paperwork filed with the check for \$141.25 and a copy of the letter received. I respectfully request that the late fee of \$400.00 be waived based on the reasons mentioned above and on our past filing history.
