We spoke by phone on Thursday, June 30, 2005 about Immokalee Senior Housing, LTD's (ISH-LTD) annual report filing for 2005. Per this conversation, enclosed is a copy of the report that was mailed on April 29. A check for \$141.25 is also enclosed. You have kindly agreed not to require the \$400 penalty fee, and for this I am very appreciative.

There were two other annual reports processed that date. It was found that our new registered agent needed to sign those two reports, so subsequently the agent took them and filed and paid the fees on-line. The agent had already filed their update earlier in the year for ISH-LTD, so I kept and mailed that annual report. The intent was to add a separate fee payment check with each annual report form, but instead, a check had been processed that included fees for all three entities. This check was subsequently voided and in all the confusion no new check was ever enclosed with ISH-LTD's report. Please accept my apology for this oversight. Much more care will be taken in the future to see this does not happen again.
