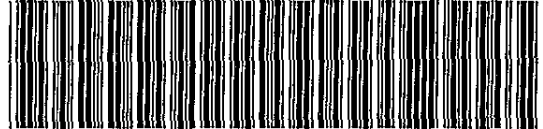

In compliance with Florida Statutes, Chapter 620, the enclosed application and Check No. 30372 in the amount of \$113.75 (\$52.50 filing fee, \$52.50 for a certified copy and \$8.75 for a certificate under seal) are submitted to register the above referenced foreign limited partnership to transact business in Florida.

Please note that the text in the Affidavit of Capital Contributions for a Foreign Limited Partnership was changed to conform to California. Section "Acknowledgments" to the California Notary Public Handbook (copy enclosed) Civil Code Section 1189 prohibits a California notary from notarizing the Affidavit of Capital Contributions for a Foreign Limited Partnership in its current format. The "Acknowledgment" Section states in part:

"A notary public may complete an acknowledgement form required in another state or jurisdiction of the United States on documents to be filed in that other state or jurisdiction, provided the form does not require the notary to determine or certify that the signer holds a particular representative capacity or to make other determinations and certificates not allowed by California law."

Therefore, at paragraph 1 the text, "BEFORE ME the undersigned personally appeared." was deleted. Also on the third line of the same section, the word "who" was deleted.
