

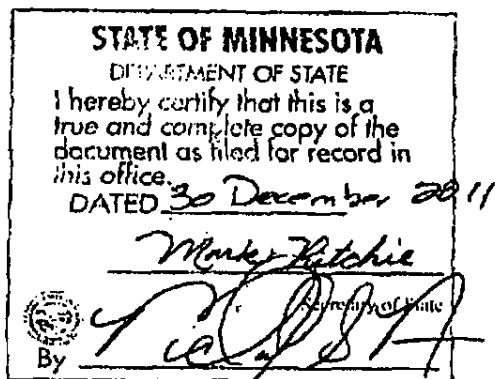

AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP**

5. All other provisions of the Certificate shall remain in full force and effect.


