SAILBOAT BEND LIMITED PARTNERSHIP AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP

Pursuant to the authority of the Minnesota Uniform Limited Partnership Act, the undersigned adopts the following amendments to its Certificate of Limited Partnership:

- The current name of the Partnership is Sallboat Bend Limited Partnership and the original Certificate of Limited Partnership of the Partnership was filed with the Minnesota Secretary of State on February 17, 2004 (the "Certificate").
- Section III of the Certificate is hereby amended to delete the reference to "Registered Office" and to delete the first sentence of the Section.
