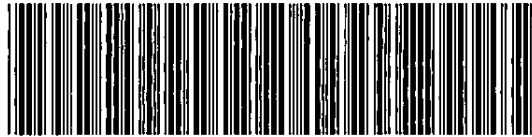

Jim Pitrat – A current partner in the firm, but will allow FL license to lapse


Elberta Yee– currently licensed, and a current partner in the firm

Rich Polep – No longer a partner in the firm, has retired


