AMENDED AND RESTATED CERTIFICATE OF LIMITED PARTNERSHIP OF LANDMARK AT JADE GARDENS, LP

This Amended and Restated Certificate of Limited Partnership of Landmark at Jade Gardens, LP (the "Partnership"), dated as of November 14, 2013, is being duly executed and filed with the Delaware Secretary of State under Section 17-210 of the Delaware Revised Uniform Limited Partnership Act by Landmark at Alexander Pointe GP, LLC, a Delaware limited liability company, as general partner, to (1) amend the Certificate of Limited Partnership to (a) change the name of the Partnership to Landmark at Alexander Pointe, LP and (b) change the name of the general partner to Landmark at Alexander Pointe GP, LLC, and (2) restate and integrate the Certificate of Limited Partnership as amended.
