Dear Clerk:

Pursuant to my telephone conversation with your office yesterday, please find enclosed a copy of the check and the Annual Report which was submitted to your office on December 19, 1997. After talking with your office, I understand that Garden La Mirada's Annual Report was received but the check was never received. I do not know where the check is, but I certainly think it was sent with the Annual Report. However, I know for a fact that the check has never cleared our bank, so therefore you have never been paid the \$156.25 due on this partnership. We filed reports on several other Garden partnerships at the same time (i.e., Garden Barcelona LP, Garden Confederate Point LP, Garden Lakewood Park LP, Garden Skipper's Pond LP, and Garden Wisperwood LP). In this regard, I am respectfully asking your office to waive the \$500 penalty in light of the above.

I have enclosed an executed Application for Reinstatement if this fee cannot be waived. The urgency I am facing is that this property is being refinanced and I need a Good Standing Certificate from your office as soon as possible. Please contact me and advise how you wish to proceed with this filing.
