Pursuant to the provisions of section 620.109, Florida Statutes, this Ohio limited partnership, whose certificate was filed with the Florida Department of State on August 20, 1993, adopts the following certificate of amendment to its certificate of limited partnership:

FIRST: Amendment: Sections 1.2 and 1.3 of the Partnership Agreement are hereby amended by deleting Sections 1.2 and 1.3 in their entirety and replacing them with the following:

Section 1.2 Name. The name of the Partnership shall be C-130 Power Master Limited Partnership.

Section 1.3 General Partner. The Partnership Agreement is hereby amended to provide for the admission of additional general partners with the consent of the General Partner and Limited Partners holding a majority of the Units.
